- 1. Bid Documents and only provision for "Bid Security Declaration" to be furnished by the Bidder.
- 2. The work is to be completed within 45 Days from the date of issue of work order.
- 3. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
- 4. Conditional tenders containing terms and condition are liable for rejection.
- 5. The Contractors are required to furnish evidence of ownership/leased or hired of machineries such as concrete mixer, vibrater, centering materials P.R.R., Vibromax Paves & Vehicles required for the concerned work failing which tenders will not be taken in to consideration.
- 6. The Contractor shall furnish a certificate along with tender to the effect that he is not related to any officer in the rank of an Assistant Engineer & above. If the fact subsequently proved to be false, the contract is liable to be rescinded.
- 7. The tenderers are to submit along with the tender a note regarding his experience on construction of similar type of works from competent authority.

- 8. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidders who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact Amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional Performance Security (APS) in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Executive Officer, Jharsuguda Municipality within Seven Days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.
- 9. If the rate quoted by the SC and ST category contractors comes to 14.99% (decimals up to two numbers will be taken for all practical purposes) less than the estimated cost after availing 10% price performance as per Para-2 of Works Department Resolution No.27748/ Dt.11.10.1977, then the tender shall be finalised by the tender accepting authority through a transparent lottery system along with other category of contractors whose rates are 14.99% less than the estimated cost. And the winner bidder has to deposit the APS within 7 (Seven) days of lottery failing which subsequently 2nd winner will be consider for award of the bid. Subsequently 3rd winner will be consider for award if the 2nd winner didn't deposit the APS from day 8 to 14 days from the date of lottery.
- No escalation of cost in respect of labour, POL, materials & other item. If any, will be entertained during the course of execution of work.
- 11. The cost of the work quoted should be written both in figure and words and in case of discrepancies between quotation in figures and words, the same in words will prevail.
- 12. The tenders are required to furnish attested copies of valid PAN Card, Labour License & valid Caste Certificate in case of ST/SC category contractors with original affidavit regarding claim of price preference if any as per rule for each tender at the time of uploading tender document to the website and originals of which are to be produced before date of opening, failing which the tender will be rejected without assigning any reason thereof.
- 13. The bill of quantity for the work will be available up to **Dt. 08.07.2022** during the period mentioned in the E-Tender.
- 14. Each tenderer is expected to inspect the site of the proposed work to know the exact working condition before tendering his offer.
- 15. The detail of work can be had in the office of the Executive Officer Jharsuguda Municipality during office hours on any working days. Relevant ISI standard PWD/PHD Specification of Government of Orissa is to be followed during course of execution.

- 16. On no account the contract work should be assigned or subject to sublet without prior approval of Municipal Council, Jharsuguda and in such event the contract may be rescinded by Executive Officer, by giving a notice in writing, The contractor should be duly liable in dimity to the Municipality for any compensation payable by Municipality to any quarter and in such case the same would be recovered from the contractor.
- 17. The contractor should abide by the fair wages clause notified by the Government in Labour Department and in force during the period of execution and shall not pay less than the fair wage fixed by Government to the laborers engaged by him for the work.
- 18. The tenderer whose tender is accepted shall forthwith. On written intimation being given to him about acceptance of tender, make requisite initial security deposit and sign the agreement within 7 day of such intimation for due fulfillment of contract in the office of Executive Officer, Jharsuguda Municipality, failing which it be liable for forfeitures of the earnest money.
- 19. Materials if any, issued by department will be supplied to the contractors from Municipality store and will be carried by contractor at his own cost and risk.
- 20. The Lowest Tendered shall submit the quality test certificate report of materials used in work. as and when required.
- 21. The contractor will use SAIL rod (Steel) for the reinforcement work and 43 grade OPC cement for execution of the work.
- 22. The contractor should arrange at his own cost necessary T&P such as pump, vibrator, concrete mixer, scaffolding materials etc. as would be required during execution of work.
- 23. The department has the right to inspect the work and can reject partly or fully each structure if found defective in their opinion.
- 24. No claim for compensation for any damage caused by rain or any other natural calamities during the execution of work will be entertained.
- 25. All safety measures are to be taken by the contractor during the execution and till final completion of work by the contractor at his own cost.
- 26. Under no circumstances interest is chargeable to the contractor for the due or additional dues if any payable to him for the work.
- 27. All tender received will remain valid for period of 90 days from the date of receipt of tender.
- 28. Payment will be made subject to availability of Municipal own funds.
- 29. In case of Cement Concrete road, use of concrete Vibrator is compulsory.

30. As per Government of Odisha Works Department Office Memorandum No.07556900052021 4559/W, Bhubaneswar, Dt.05.04.2021. the APSD has been fixed as detailed bellow in the tabular format:
